Exchange Student: definition and types of enrolment

<u>Definition</u>: An International Guest Student is a student who takes one or more subjects from the regular education programme of Wageningen University within the framework of a student exchange programme in which Wageningen University participates.

The study at Wageningen University is part of the student's study programme at another Institute for higher education abroad.

The subjects of the regular education programme of WU are included in the Study handbook 2014/2015 (https://ssc.wur.nl/Handbook). Please note that some subjects have a set maximum number of participants. Please contact your exchange coordinator for information.

Specific conditions for registration for exchange students are:

- The International Guest Student cannot be registered as a regular student during the period of exchange.
- The maximum duration for Registration as a 'Guest Student' is 12 months (during one academic year). In that period the 'Guest student' can register for courses up to a maximum of 60 credits. In case a student has registered for less than 60 credits in that period, a request for extension of the enrolment can be submitted to the SSC (only, if possible within the conditions of the exchange programme).
- Written permission from the Examination Committee of Wageningen University is needed to register for AV (thesis) and AMC (academic master cluster) subjects.
- Exchange students cannot register for a PT (internship) subject.

Within the type of registration of 'International Guest Student' a distinction is made between:
